NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF HORIZON METROPOLITAN DISTRICT NO. 4 AS FOLLOWS:

- 1. The Board of Directors hereby adopts the amended 2023 budget for its General Fund, as set forth in Exhibit A attached hereto ("Amended 2023 Budget"), which Amended 2023 Budget appropriates additional funds for unanticipated expenditures:
- a. <u>General Fund</u>. Available revenues in the General Fund are hereby appropriated in the following amount to pay for expenditures and fund transfers identified in the Amended 2023 Budget:

Amendment to 2023 Adopted Budget:	\$ 5,170

- 2. The adoption of the Amended 2023 Budget reflects a balanced budget as required by State law.
 - 3. This Resolution shall take effect on the date and at the time of its adoption.
